The Solar Impulse Foundation reserves the right to change this Privacy Policy at any time without notice to you. You are therefore responsible for regularly reviewing this Privacy Policy. This Privacy Policy covers Solar Impulse Foundation's processing of personal identifying information that the Solar Impulse Foundation collects when you are on the Website and when you use services on the Website. This Privacy Policy does not apply to the practices of any companies or legal entities that the Solar Impulse Foundation does not own or control nor to any person that the Solar Impulse Foundation does not employ. The Website is provided subject to the acceptance of the Privacy Policy with no reservations. Consent is deemed issued when the Website is accessed and/or used.

Information collection and use

The Solar Impulse Foundation does not collect personal identifying information when you access and browse the Website without disclosing your personal data (except cookies; see below under "cookies"). The Solar Impulse Foundation collects personal identifying information when you register on the Website and when you use certain products or services on the Website. When you register on the Website, the Solar Impulse Foundation asks for your name, e-mail address, and some other personal information. Once you register and/or sign-in on the Website, you are not anonymous to the Solar Impulse Foundation. Information sharing and disclosure

(i) the Solar Impulse Foundation needs to send the information to third parties to check your identity and background;

the Solar Impulse Foundation needs to send the information to third parties who work on behalf of or in connection with the Solar Impulse Foundation to provide a product or service to you, such as the World Alliance for Efficient Solutions, (these third parties do not have any rights to use the personal identifying information that the Solar Impulse Foundation provides to them beyond what is necessary to provide a product or service to you); the Solar Impulse Foundation responds to courts or authorities; or

the Solar Impulse Foundation deems your actions on the Website as violating Solar Impulse Foundation Website Terms and Conditions or any other Solar Impulse Foundation's guidelines or rules applicable for specific services.

Cookies
